Therefore, graduate education must refocus teaching on both the ability to decisively function in highly technical, big data environments and on the need for interpretation of high quality analytic outputs. The curricula of the future will necessarily incorporate coding as a technical skill to be acquired and managed in the workplace, privacy education and more. Enhanced teaching of technical and analytic skills today will prepare tomorrow's workforce to be problem solvers managing both machine and human assets.
