Shaun Harper is an expert on diversity, equity, and inclusion in educational, corporate, and policymaking contexts. He has published 12 books and more than 100 peer-reviewed journal articles and other academic publications. He also has procured \$25.9 million in foundation grants, \$18.6 million in contracts, and \$6.5 million in investments and philanthropic gifts for the center he founded. Professor Harper's research has been cited in over 25,000 published studies across an array of academic fields. He served as the 2020-21 American Educational Research Association president and the 2016-17 Association for the Study of Higher Education president. The New York Times, Washington Post, Los Angeles Times, Wall Street Journal, The Atlantic, Sports Illustrated, and several hundred other news outlets have quoted Dr. Harper and featured his research. He has been interviewed on CNN, MSNBC, ESPN, PBS NewsHour, and NPR. Ranked the nation's 4th most influential professor in Education Week in 2023, he has testified twice to the U.S. House of Representatives and his studies have been repeatedly cited in amicus briefs submitted to the U.S. Supreme Court. He was inducted into the National Academy of Education in 2021 and appointed by U.S. President Joe Biden to the National Board for Education Sciences in 2022. Professor Harper has served on 130 doctoral dissertation committees. Over 3 million people have read articles he wrote for the Washington Post, Forbes, Ebony, Rolling Stone, Fortune, Los Angeles Times, CNN.com, the Grio, and The Root. The U.S. Air Force, Nike, Zoom, T-Mobile, Google, Microsoft, NBC Universal, Anheuser-Busch, Mattel, Major League Baseball, and the National Football League are among the more than 400 businesses, agencies, and institutions with which Dr. Harper has worked.
