
What is Public Policy?

They learn to use data analysis and an understanding of our economic and political institutions to design practical solutions that make a difference in the complex challenges our future faces.

Our alums have worked as agents of change across numerous public and private organizations, serving in roles such as data analysts in think tanks and private consulting firms, policymakers in state and federal government, and managers in healthcare and non-profit organizations.



B.S. in Public Policy

At USC Price, a degree in Public Policy equips students with a blend of theoretical knowledge and real-world skills. Our curriculum integrates economics, political science, and quantitative methods with practical expertise in communication, leadership, and policy analysis and implementation. Students gain the tools to analyze complex challenges and drive meaningful change at the local, state, and federal levels turning vision into action for the common good.



DEGREE REQUIREMENTS

• 128 units minimum for one degree (e.g. Public Policy B.S.)

- 160 units minimum for two degrees (e.g. Public Policy B.S. + another major program)
- GE and WRIT requirements are the same
- No foreign language requirement

CORE MAJOR REQUIREMENTS

Public Policy major requires students to complete MATH 117 and PPD 203. There are several ways to fulfill MATH 117 requirement; see below.

MATH 117: Introduction to Mathematics for Business and Economics

- Take the math placement exam to determine if you need to take MATH 117
 - If you place into MATH 118/MATH 125, then you will be given a course waiver for MATH 117
- If you have a score of 4 or 5 on the AP Calculus exam, then you will be given a course waiver for MATH 117

• PPD 203: Economic Analysis for Public Policy

- Pre-requisite/co-requisite is MATH 117 or higher
- Offered each fall semester

- Students can satisfy this requirement in one of two ways
 - 1. If you have a score of 4 or 5 on the AP Microeconomics exam, then you will be given a course waiver for PPD 203
 - 2. If you transferred in the equivalent of ECON 203, prior to matriculating at USC

 - Must get at least 140 hours of work from the internship

Students have an opportunity to take PPD 431 capstone as a regular semester course or participate and take it as part of the Maymester program.




